1. GENERAL INFORMATION

Raja Mahendra Pratap Singh University, Aligarh invites online applications from eligible candidates for admission to the Ph.D. Programme for the Academic Session 2026–2027 in the subjects/disciplines in which seats and eligible Research Supervisors are available. Admissions shall be made in accordance with the UGC Regulations, 2022 and the applicable Ph.D. Ordinance/Rules of Raja Mahendra Pratap Singh University, Aligarh.

1.1 The Ph.D. Programme shall be offered in Full-Time and Part-Time mode, subject to the applicable University rules and availability of an eligible Research Supervisor.

1.2 Reservation shall be applicable as per the reservation policy of the Government of Uttar Pradesh and the rules adopted by the University.

1.3 Candidates claiming reservation benefits shall produce valid category/caste/EWS/PwD certificates issued by the competent authority. Candidates from outside Uttar Pradesh shall be treated according to the applicable University/Government reservation rules.

1.4 The list of vacant seats and eligible Research Supervisors shall be subject-wise and may be revised depending upon availability at the time of admission.

1.5 A candidate may seek admission in only one subject/interdisciplinary area, subject to the relevant eligibility and availability of seats.

1.6 All admissions shall be provisional until verification of original documents and fulfilment of all prescribed conditions.

1.7 The decision of the competent authority/Ph.D. Admission Committee of the University in matters relating to admission shall be final, subject to the applicable rules.

2. ELIGIBILITY CRITERIA

2.1 Candidates seeking admission to the Ph.D. Programme shall possess a Master's degree or a professional degree declared equivalent to the Master's degree by the corresponding statutory regulatory body, with at least 55% marks in aggregate or an equivalent grade in the applicable grading system.

2.2 Candidates having an equivalent qualification from a foreign educational institution shall satisfy the applicable recognition/equivalence requirements of the competent authority.

2.3 Candidates appearing in the final year/semester of the qualifying Master's degree programme may apply provisionally, subject to completion of the required qualification within the period prescribed by the University.

2.4 A relaxation of 5% marks, from 55% to 50%, shall be applicable to candidates belonging to SC/ST/OBC (Non-Creamy Layer)/Differently-Abled categories and other categories entitled to relaxation under applicable Government/UGC rules.

2.5 Candidates possessing an M.Phil. degree/course work qualification shall be considered as per the UGC Regulations, 2022 and the University's Ph.D. Ordinance/Rules.

2.6 Admission in allied/interdisciplinary subjects shall be permitted only where the proposed research area, vacant seat, eligible Research Supervisor and necessary academic/physical facilities are available.

3. CATEGORIES EXEMPTED FROM RESEARCH ENTRANCE TEST

Subject to the UGC Regulations, 2022 and the RMPSU Ph.D. Ordinance-2024, the following categories may be exempted from the Research Entrance Test, wherever applicable:

- (a) Regular teachers of the University and its affiliated/aided colleges who fulfil the prescribed conditions.
- (b) Candidates who have qualified UGC/CSIR-NET/JRF or fellowship examinations recognised for Ph.D. admission, subject to validity and applicable rules.
- (c) Candidates who have qualified UGC-NET/CSIR-NET for Ph.D. admission, wherever applicable.
- (d) Candidates having a valid GATE score/qualification, where recognised and applicable to the concerned subject/research area.
- (e) Candidates possessing an M.Phil. degree, where eligible under the applicable UGC/University provisions.
- (f) Candidates covered under any other category specifically exempted by the UGC Regulations, Government orders or RMPSU Ph.D. Ordinance-2024.

4. PROCEDURE FOR ADMISSION

4.1 Eligible candidates shall submit the prescribed online application form through the University Research/Admission Portal within the notified schedule.

4.2 Admissions shall be made through the Research Entrance Test (RET), except for candidates falling under the exempted categories specified in the applicable rules.

4.3 Subject-wise vacant seats shall be notified separately/along with this notification. Seat allocation shall be made subject to reservation, availability of Research Supervisors and other applicable conditions.

4.4 Candidates in the exempted category shall also submit the online application form. Where permitted by the University, such candidates may appear in the RET so that their candidature may be considered through the applicable route.

4.5 Candidates qualifying the RET shall be considered for further admission stages, including interview/viva-voce and evaluation of the research proposal, as prescribed by the University.

4.6 The minimum qualifying marks in the RET shall be as prescribed under the applicable UGC/University rules, including permissible relaxation for reserved categories.

4.7 Merit and final selection shall be prepared in accordance with the RMPSU Ph.D. Ordinance-2024, UGC Regulations, 2022, reservation rules and the criteria notified by the University.

5. PATTERN OF RESEARCH ENTRANCE TEST (RET)

The Research Entrance Test shall be conducted in the pattern notified by Raja Mahendra Pratap Singh University, Aligarh. The test may consist of 100 objective-type questions carrying one mark

each covering Research Methodology/Research Aptitude and the concerned subject ,with a duration of 120 minutes; 30 Questions from research methodology/General aptitude and 70 Questions from the subject concerned. The detailed syllabus of RET shall be the same as that of UGC – NET/CSIR-NET. The qualifying criteria shall be 50 % of the total marks.

The final RET pattern shall be governed by the notification issued by RMPSU for the session 2026–2027.

6. APPLICATION FEE

The application fee once deposited shall not ordinarily be refundable. Candidates should verify all details before final submission/payment.

- Aadhaar Card/other identity proof as permitted.
- Marksheets and certificates of High School, Intermediate, Bachelor's and Master's degree/qualifying examination.
- Category/EWS/PwD/OBC/SC/ST certificate, wherever applicable.
- NET/JRF/CSIR-NET/GATE/SLET or other qualifying/exemption certificate, wherever applicable.

8. IMPORTANT INSTRUCTIONS

- Candidates must carefully read the eligibility conditions, subject-wise vacancy and Supervisor list before applying.
- Original certificates/documents must be produced at counselling/document verification. Failure to produce original documents may result in cancellation of candidature/admission.
- Photocopies, downloaded internet copies or provisional documents shall be accepted only where specifically permitted by the University.
- The University reserves the right to increase/decrease/withdraw seats or modify the admission schedule/pattern in accordance with rules and administrative requirements.
- Candidates are advised to visit the official University website regularly for notices, corrigenda, examination schedule, counselling schedule, merit list and other updates.
